



MEMBERSHIP

In 2021, the Stakeholder Relations team evolved into the Development Team, with the dual dedicated focus of both growing the game and supporting members.

Following the impact of COVID-19 on the 2020 season, all 37 associations were able to return to competition. As the pandemic continued to cause upheaval for community sport, Netball SA continued to support members through the disruptions and restrictions that challenged the 2021 season, as well as preparing for potential ongoing interruptions.


Netball SA's fortnightly 'The Game Plan' newsletter, created especially for associations and clubs, continued to provide content on governance, funding opportunities, products and pathways and club development.

Council Meetings returned to their regular face-to-face format, with virtual attendance remaining an option for those unable to be physically present. In addition, Regional Networking Sessions were introduced as a way of facilitating interactions and information sharing among Netball SA's regional associations.

Over the course of the year, the Development team visited nine regions across the state to offer support during the 2021 season. This included the Berri pre-season match and clinics with the Adelaide Thunderbirds, as well as trips to Port Lincoln, Mount Gambier, Port Pirie, Kadina, Great Southern, Southern Hills and Central Ranges.

As part of the latest stage of the national digital transformation project, Netball SA affiliated organisations commenced the transition from MyNetball to PlayHQ. Netball SA's associations and clubs received dedicated support from the state's Netball Australia Program Change Coordinator to help facilitate the move. As part of an initial pilot, summer associations were the first to transition, with winter associations commencing their onboarding ready for 2022.

Suncorp NetSetGO is a national product, providing children between the ages of 5-10 years an opportunity to progressively develop netball skills.

In 2021, South Australia had 196 centres, including 15 new centres. A total of 4,972 participants registered to a Net, Set or GO program. The 2021 program recorded a 46% growth in participants.

NetSetGO on-court activations were held at three of the Adelaide Thunderbirds' home games, with a total of 60 program participants involved across the season. Piccadilly Netball Club participated in the season opener and Mundulla Netball Club, of Adelaide Thunderbird Maisie Nankivell's hometown, participated in the Round 5 Indigenous Round. The Adelaide Entertainment Centre Round 7 match featured Millicent Netball Club – Netball SA's oldest NetSetGO centre, having been aligned with the program for 13 years.

In 2021, the Adelaide Thunderbirds School Holiday clinics experienced its most successful year to date, with 1,482 participants aged 5–13 years attending a clinic.

Adelaide Thunderbirds squad athletes attended all clinics, providing a great opportunity for young South Australian netballers to meet and learn from their idols.

A key focus at the clinics was to keep participants engaged with a variety of activities to develop their skills and learnings, encourage repeat participation and build the connection between Adelaide Thunderbirds athletes and grassroots participants.

At the July School Holiday Clinics, a new format for the program was introduced with the clinics broken into defending, attacking and shooting.

The July clinics recorded the highest ever participation of any clinic.



SCHOOL PROGRAMS







Netball SA continues to provide opportunities for primary and secondary school students throughout South Australia to engage in netball, primarily through the Sporting Schools Program and Subway Thunder Cup competition.

SPORTING SCHOOLS

The Sporting Schools program is an Australian Government initiative designed to help schools to increase children's participation in sport and to connect them with community sporting opportunities.

Participating school netball programs were held across 56 primary schools and 15 high schools.

In 2021, the Sporting Schools program experienced exceptional growth of 28%, with 2021 student participation increased by 2,273 from 2020. More than 8,000 students participated in the program overall.

SUBWAY THUNDER CUP

Subway Thunder Cup is a participation-based competition for schools. The weekly competition, delivered in Terms 2 and 3, enables children from Years 3-7 to play netball and develop their skills.

The program saw 330 students participating across the three age groups, representing a growth of 6%.

Adelaide Thunderbird athletes connected with players across the program, including a special appearance at the competition's Childhood Cancer Awareness Round to help raise awareness for the Childhood Cancer Association. This was held in support of Subway Thunder Cup participant and cancer survivor, Holly Altamura.

SPECIALIST SCHOOLS PROGRAM

In 2021, Netball SA undertook a review of the Specialist Schools program. The outcomes of the review will see Netball SA rollout a new and improved Specialist School program in 2022.

COUNTRY CHAMPIONSHIPS

With the impact of COVID-19 forcing its cancellation in 2020, Netball SA's Country Championships made its triumphant return in 2021.

Held annually on the June long weekend, the competition attracts the best of regional talent from across the state to Netball SA Stadium to participate in the three-day competition.

More than 1,000 players from over 26 associations competed across 101 teams over 526 matches.

In 2021, the state's biggest netball event bounced back strongly hosting the biggest competition of the last 15 years.

U11s also joined the Country Championships for the first time, participating in a one-day competition.

In another first, The Advertiser live streamed the event, bringing the competition to the communities of associations and supporters who were unable to attend. Covering 101 matches, this was a historymaking live stream event for the media outlet and Netball SA.

Port Lincoln took out the Seniors B Grade, while Western Border claimed the A Grade title.

Netball SA extends its sincere thanks to the Country Championships Organising Committee for the dedication and hard work put into this year's competition.

ACADEMY PROGRAM

Netball SA established the Academy Program throughout South Australia for talent identified players, coaches and umpires to help them reach their potential.

The program aims to decentralise the delivery of developmental and high-performance programs to South Australian member associations and to develop links between the regions, Netball SA and the South Australian Sports Institute.

Nine academies throughout the state participate in the program, which is conducted from February to October.

The three-day event begins with the skills day, before two days of competition.

In 2021, the SAASTA Aboriginal Netball Academy joined the competition for the first time.

Murray Academy took out Division 1 of the competition and Adelaide Academy came out on top for Division 2.

SAASTA ABORIGINAL NETBALL ACADEMY

The South Australian Aboriginal Secondary Training Academy (SAASTA) Aboriginal Netball Academy provides Aboriginal and Torres Strait Islander high school students with a unique program of educational outcomes and netball development.

The netball component of the academy saw students participate in the Foundation Coaching Accreditation, Beginner Umpire Workshop, skill development and match play opportunities against Henley High School, St Mary's College, SEDA College and Pulteney High School.

SAASTA students also completed subjects that go towards their SACE. Over two years, students can study either Stage 2 Sports Science or Aboriginal Studies. They can also study a Certificate III VET option such as Sport and Recreation, Community Services, or Fitness and Hospitality.

In 2021 the program was delivered every Thursday at St Clair Recreation Centre during the school year.

In preparation of the SSN Indigenous Round, SAASTA Aboriginal Netball Academy students collaborated with local Indigenous artist, Shane Cook to design the 2021 Adelaide Thunderbirds Indigenous dress. The dress was worn on three occasions during the season, aligning with the 2021 National Reconciliation Week and NAIDOC Week.

SAASTA students also participated in the Indigenous dress presentation to the athletes which followed a traditional cleansing ceremony.

At the Adelaide Thunderbirds Indigenous Round, held in Round 5, SAASTA Aboriginal Netball Academy and Kaleteeya Netball Club showcased their talent at the event's curtain raiser.

Adelaide Thunderbird Matilda Garrett was named

SAASTA ambassador and participated in skills development clinics with the students.

Students connected with Adelaide Thunderbirds Assistant Coach Cathy Fellows who also ran skills development clinics with the students.

In 2021, SAASTA competed in the Netball SA Academy Games for the first time. They made their mark on the games, finishing in the top half of the competition, placing fifth of the ten academies.

Students celebrated the year at the 2021 SAASTA Graduation on 4 November at the Adelaide Convention Centre, where Netball SA presented three key awards.

First introduced in 2013, the annual tournament provides women with an intellectual disability the chance to compete at a national level and quickly became a highlight of the annual Australia Post One Netball calendar.

BENCH OFFICIALS RECEIVED AN ACCREDITATION

The Netball SA Premier League is South Australia's pinnacle netball competition, comprising of the state's best talent and emerging stars.

It provides athletes, coaches, umpires and officials with a highly competitive environment in which to further develop their skills, and is also an important feeder program for national opportunities within the netball pathway.

Following a significantly disrupted 2020 season due to COVID-19, the league bounced back strongly with the return of the annual Pre-season Tournament held in March.

BarTV Sports joined the league for the first time, live streaming all Court 1 games of the minor round and the finals series. 2021 was also the first time the Reserves Division was live streamed.

The onset of COVID-19 in South Australia caused a temporary break in training and competition with the season placed on hold for two weeks in July.

An elevated 2021 Indigenous Round saw seven clubs design Indigenous dresses – with South Adelaide, Metro Jets, Newton Jaguars and Tango launching Indigenous dresses for the first time. The rounds, which was celebrated over both Rounds 5 and 6 were launched with a Welcome to Country and 'meeting place' formation involving all clubs.

In 2021, Woods Panthers evolved into South Adelaide Netball Club, following its partnership with South Adelaide Football Club. They made their presence known, making their first ever Grand Final appearance coming up against Matrics for the Reserves title.

In a history making bid to claim three championship titles in a row, Matrics took out the Reserves Division premiership, with a one goal win over South Adelaide.

Contax finished Minor Premiers of the Premier Division and went on to claim the title in a thrilling one goal victory over Matrics Netball Club.

Netball SA lovingly remembers Premier League players Ivy-Rose Hughes (Matrics Netball Club) and Charlotte Agostino (Oakdale Netball Club), both forever a part of the Netball SA family.

11 COACHES IN THE NETBALL SA TARGET COACH PROGRAM

With netball events back in full swing in 2021, an exciting South Australian netball calendar provided some unique opportunities for coaching development.

Aligned with the Adelaide Thunderbirds' pre-season match in Berri against the West Coast Fever, a back bench coaching session provided regional coaches with a chance to develop their skills through the interactive workshop.

Later in the season, a second back bench coaching session was aligned with the Adelaide Thunderbirds' Adelaide Entertainment Centre marque match against the NSW Swifts.

A Development Course was also aligned with the eve of the 2021 Country Championships to increase the accessibility of the course to regional coaches. All four participants in the pilot program were successful in achieving their accreditation.

2021 recorded a strong participation in the Online Foundation, Online Development and Face-to-Face Development Course, including the Online Foundation Course increasing from 192 to 367 accreditations in 2021.

With the launch of the inaugural Netball SA Awards Gala, the event recognised the Coach of the Year - Community (presented by Woolworths) and Performance Development Coach of the Year (presented by Woolworths). Jake Taylor from Hummocks Netball Club and Leanne Eichler from Contax Netball Club respectively took out these awards for their significant contributions to coaching.

In 2021, Netball SA introduced the Netball SA Academy Targeted Umpire Squad (ATUS). The ATUS was created with the purpose of developing South Australia's emerging umpires and formed part of Netball SA umpire pathway.

ATUS enables umpires to undertake development and identified training activities to strengthen umpiring in each region. The ATUS is supported by Netball SA and the Academy Targeted Umpire Panel which was led by Georgina Sulley-Beales.

South Australian umpire Rebecca Ferguson made her SSN debut in Round 11 of the 2021 season. Joining Georgina Sulley-Beales in the SSN, this represents the first time two South Australian umpires have been contracted to the SSN in the same season.

14-year-old Lucas Gulin joined the Netball SA Premier League competition – the youngest member of the Premier League Umpire Squad. The achievement marks another exciting milestone in Lucas' progression through the Netball SA umpire pathway. At the age of 12 he was the youngest South Australian umpire to receive a B Badge and continues to travel weekly to both contribute to umpiring and receive mentoring to further his progress.



ADELAIDE THUNDERBIRDS

The Adelaide Thunderbirds' 2021 season was marked with several exciting firsts for the club. These achievements were particularly special within a season that for a second year continued to be affected by the impact of COVID-19.

On 16 April the club hosted the West Coast Fever in a pre-season match held in Berri. The event marked the first time SSN teams have competed in regional South Australia. The sold-out game was followed by clinics giving junior netballers a chance to connect with both teams. The Adelaide Thunderbirds then hosted the Fever at Netball SA Stadium on 18 April in what was the club's biggest Fan Day attendance to date. Following the event's cancellation in 2020, this represented a strong return for this valued fan experience.

Despite the continued upheaval COVID-19 caused the season, the club was proud to host six of the seven planned home games in South Australia – the most of any club. South Australia also played host to the four NSW and Victorian sides in Round 11 before the league relocated to Queensland, where the clubs played out the remainder of the season for Rounds 12-14.

For the third year in a row, the Adelaide Thunderbirds placed seventh on the ladder. However, their season showcased the exciting player connections that the club is continuing to build. Highlights included the win over eventual premiers the NSW Swifts in the Adelaide Entertainment Centre Round 7 blockbuster - played in front of the club's largest ever SSN crowd. This, along with a win over the Sunshine Coast Lightning in Round 12, marked firsts for the club's SSN history.

The Adelaide Thunderbirds celebrated the league's Indigenous Round across Rounds 5 and 6. The 2021 Indigenous dress design was created through a collaboration with local Indigenous artist Shane Cook and the SAASTA Aboriginal Netball Academy. Before

wearing the dress for the first time, all club players and staff participated in a traditional cleansing ceremony at Netball SA Stadium.

Hannah Petty, who came through the Netball SA pathway and was co-captain in 2020, was named captain for 2021 – the youngest captain in the league. Her impact within the club was recognised when she won the 2021 Spirit Award (presented by Valour).

After a standout on court performance as an elevated training partner in 2020, South Australian talent Georgie Horjus was signed as a contracted 10 squad member in 2021 at just 19 years of age. Her stellar contribution to the team throughout the 2021 season was recognised when she was crowned Subway Club Champion.



NETBALL SA STADIUM

Due to the impact of COVID-19, 2021 was another difficult year for Netball SA Stadium operations. Despite South Australia's relatively favourable position during the height of the pandemic, frequently changing restrictions including those relating to borders presented ongoing challenges for the venue.

The venue operated within restricted capacities, limiting or at times closing the venue to spectators.

When South Australia locked down in July, working with SA Health, the stadium was converted into a major testing facility for 10 days.

Outside of the lockdown, for the most part, regular competitions ran with minimal interruptions, and full seasons were completed for almost all competitions hosted at Netball SA Stadium.

The stadium was run under a COVID Management Plan, COVID Safe Plan and adaptive restrictions, which allowed operations to continue relatively normally. Unfortunately, some major bookings were forced to cancel or postpone due to uncertainty with capacities, restrictions, and boarder conditions. However, as the venue focused on its multi-use positioning, several major events were able to go ahead including Aussie Gold Cheer & Dance, FLAVA Dance Concert, Colonel Light Gardens Primary School Concert, SAPSASA, CESA, SSN Hub, SUNA Winter, COVID Testing Station, India COVID Crisis Fundraiser and five Adelaide Thunderbirds home

As Netball SA continue to upgrade the stadium, it has endeavoured to minimise disruptions to patrons for all events and will continue to do so through the next stages of development. We thank all visitors for their ongoing patience through 2021 developments. Netball SA looks forward to continuing to welcome more patrons to the home of netball in South Australia.

NETBALL SA EVENTS

It was a year of 'firsts' for Netball SA's events calendar. This began with the Adelaide Thunderbirds first SSN preseason match in regional South Australia. The 'Mighty Murray Clash' on 16 April in Berri saw the Adelaide Thunderbirds host the West Coast Fever thanks to support of Berri-Barmera Council, Berri Hotel, and the Berri Netball Club. The SSN stars were greeted by a soldout crowd. The clinics with both teams which followed on 17 April also proved popular for the local junior netballers.

On 18 April, the Adelaide Thunderbirds' Fan Day hosted the Fever at Netball SA Stadium, attracting the largest crowd of the event's history.

The Adelaide Thunderbirds Season Launch was celebrated with club's volunteers and staff breakfast on 21 April, followed by the corporate launch at Hotel Indigo Adelaide on 22 April.

The Adelaide Thunderbirds' season officially began on 2 May with Round 1 at Netball SA Stadium and introduced an elevated event presentation focus.

For the first time, Netball SA hosted the two biggest events on its calendar on the same weekend. The June long weekend saw Country Championships hosted at Netball SA Stadium, with the Adelaide Thunderbirds' Adelaide Entertainment Centre blockbuster hosted on 12 June. Both proved a great success, with the Country Championships recording the highest participation of the last 15 years, and the Adelaide Entertainment Centre match drawing the club's largest SSN crowd to date.

The season was rounded out with the inaugural Netball SA Awards Gala. As netball's night of nights, the event celebrated community netball, Premier League and the Adelaide Thunderbirds at the Adelaide Entertainment Centre. The gala attracted 341 people and was also streamed online allowing Netball SA's community to join from across the globe.



GRANTS

NETBALL SA STADIUM REDEVELOPMENT

2021 saw the completion of the \$6.1 million facility development grant received by Netball SA in 2016 thanks to the Weatherill State Labor Government for Netball SA

Among the final stages of this project, in 2021 the grant allowed for the renovation of the external toilets, adding a change facility and shower to the amenities. At the conclusion of 2021, final works are underway to commission the state-of-art entry turnstiles at the stadium's main entrance.

As a vital boost to the stadium's ongoing development plan, Netball SA were the proud recipients of a \$12 million grant from the Marshall State Liberal Government, which was further bolstered by an additional \$6 million from the Morrison Federal Liberal Government.

Planning is now underway for Stage 2 of the stadium's facility development.

In 2021, Netball SA were proud to launch a Walking Netball product thanks to grant funding from the South Australian Government.

The program launched with three 'Come and Try' competitions at Netball SA Stadium from 9-23 September, allowing interested participants to trial the Walking Netball experience.

Sessions were run by Netball SA Community Coaches and staff and included targeted warm ups and cool downs, rule introduction, skills refreshers, and movement and agility activities, followed by game play. A free morning tea also provided participants with the chance to form social connections within the competition.

The competition then moved to an eight-week paid program. With no ladders, fixtures or points, the competition was designed to encourage 'Walk Up' Walking Netball and increase participation.

Due to popular demand, the Walking Netball product was licensed to interested affiliated associations and clubs to run their own competitions.

MARKETING AND COMMUNICATIONS

Netball SA's Marketing and Communications continue to the help promote the sport in South Australia.

Key campaigns and communications support the Netball SA, Adelaide Thunderbirds, Premier League and Netball SA Stadium brands.

Membership and ticketing were supported by the launch of the 'Watch her Fly' campaign. The campaign was integrated across digital advertising as well as radio and outdoor advertising thanks to partnerships with SAFM and JCDecaux.

The Adelaide Entertainment Centre margue match was a key priority, with efforts in this space rewarded with the match recording the highest ever attendance of any Adelaide Thunderbirds Suncorp Super Netball match to date.

In a first for the Adelaide Thunderbirds in the SSN, the sold-out pre-season match against the West Coast Fever in Berri provided an exciting chance to showcase the elite SSN brand to South Australia's regional community.

The launch of above the line advertising to support school holiday clinics recorded a positive return on investment, with the June clinics recording the highest participation on record.

The impact of COVID-19 on competitions and programs continued to be a key focus of communications across the year, with Netball SA committed to providing the latest updates affecting the netball community.

In 2021, Netball SA was proud to partner with The Advertiser to bring major netball competitions online through livestreaming. This included a history-making live stream for the media outlet, with 101 matches made available online in the 2021 Country Championships. The Advertiser also live streamed 42 matches of the 2021 Academy Games.

Media opportunities were optimised across the business including coverage across television, digital, radio, print and broadcast, earning an estimated media value of 1.4 million.

Indigenous Rounds across both the Adelaide Thunderbirds and Premier League was a key focus. For the Adelaide Thunderbirds, the club celebrated the 2021 dress design created as a collaboration between local Indigenous artist Shane Cook and SAASTA Aboriginal Netball Academy students. Within Premier League, 2021 marked a record seven clubs designing an Indigenous dress created specially for the round.

After a turbulent 2020, the ticketing team continued to navigate rapidly-changing government guidelines to ensure adherence to COVID-19 management plans and local health advice.

The season attracted more than 19,000 spectators, however most games were impacted by a 75% restriction on venue capacity due to COVID-19 guidelines.

In 2021, the club achieved its highest ever crowd in a Suncorp Super Netball match, with 6,158 Adelaide Thunderbirds fans attending the Adelaide Entertainment Centre blockbuster event.

The marquee game at Adelaide Entertainment Centre enabled the club to elevate the match day experience for fans and supporters. It was also supported by new corporate packages including courtside seating and corporate boxes.

At Netball SA Stadium, four out of the five home days were sold out events.

Out of the regular season, pre-season events also proved a resounding success, with the Berri regional match attracting a sell out crowd and Fan Day at Netball SA Stadium recording the largest Fan Day crowd in the club's history.

The Adelaide Thunderbirds' gross viewership increased to more than 574,000 representing a 15% year of year increase and the club was the only one to record an increase within the Suncorp Super Netball league. This is attributed the club receiving one additional free-to-air broadcast game, through Channel 9's GEM compared to

Indigenous Round (Round 5) was the Adelaide Thunderbirds' most viewed game of the season, the highest of any club for the round and the highest in the club's SSN history.

The average ratings for the Adelaide Thunderbirds once again outperformed the local A-League, NBL and all female sporting codes.



OUR PARTNERS

In 2021, Netball SA continued to face commercial challenges due to an uncertain landscape. Following the departure of Premier Partner, Priceline Pharmacy at the end of 2020, attention quickly shifted to securing renewals. With most of the portfolio retained, this resulted in \$1.07 million in commercial revenue.

With COVID-19 continuing to impact partners both locally and nationally, the increased focus on digital opportunities continued. However, Netball SA was proud to host several partner events providing valuable opportunities for networking and collaboration.

2021 saw Principal Partner, Subway welcomed to the Adelaide Thunderbirds family. Subway's support extends from grassroots through to the elite level, ensuring investment into netballers of all ages across the state.

The Subway partnership was successfully launched in stores across Adelaide and was integrated on-air through SAFM as well as local news coverage. Engagement with the franchisees has been key to the success of the partnership.

New merchandise and apparel partner, Valour also joined Netball SA in 2021. With this came the unveiling

of a series of new Adelaide Thunderbirds dresses and a high performance and merchandise range.

As a new wine partner in 2021, Fox Creek offered an exciting new corporate experience at the Adelaide Entertainment Centre through the launch of the Fox Creek Deck. The partnership also supported a premium corporate networking event at Fox Creek winery and Netball SA stadium supply.

A new media partner in 2021, JCDecaux helped launch a successful outdoor campaign for membership and ticketing.

In 2021, Netball SA also partnered with Teamgage for the first time, offering valuable support for teams across Netball SA staff.

Netball SA thanks its partners for the generous support provided in 2021. The many successes off the court and netball's ability to uplift and empower communities were made possible together.

OPERATING PERFORMANCE

COVID-19 continued to take its toll on the sporting landscape with netball continuing to be impacted.

In South Australia, the ongoing government restrictions meant Netball needed to deal with uncertainty around participation, spectator numbers, venue capacity and the increased running costs associated with government mandated measures.

With a strong commitment from participants, clubs, associations, and spectators, Netball did bounce back from the results incurred in the 2020 financial year.

Netball SA incurred an operating surplus for the year of \$629,723 (2020: \$311,809 deficit).

However, the audited financial statements show a surplus for the financial year of \$2,073,328 (2020: \$4,102,643). This was as a result of recognising Capital Grant revenue, which could only be used for upgrades to the stadium and surrounds at Mile End.

While the Netball SA audited financial statements show a surplus for the 2021 year, this was impacted by extraordinary items of income due solely to COVID-19. These include a once off government grant of \$700,000 and continuing Job Keeper and government subsidies of \$919,737.

The ongoing disruptions of the pandemic meant that Netball SA was not fully able to deliver against its strategic objectives for the financial year.

Factors that contributed to this include:

- Reduced participation across the state (while participation recovered significantly from 2020, it is not back to pre-pandemic levels)
- Venue capacity reduced by 25%, impacting facility hire and entry fees
- Cancellation of external events
- Increased costs due to government requirements associated with the COVID Management Plan and COVID Safe Plan.

The pandemic continued to present NSA with financial challenges, but with the support of state and federal governments, it managed to continue operating.

Netball SA's focus for the new financial year will be to continue to strengthen Netball SA's financial position.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2021

NOTE 1 - SIGNIFICANT ACCOUNTING POLICIES

The financial statements cover South Australian Netball Association Incorporated as an individual entity. South Australian Netball Association Incorporated is an association incorporated in South Australia and operating pursuant to the Associations Incorporation Act (SA) 1985.

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

New or amended Accounting Standards and Interpretations adopted

South Australian Netball Association Incorporated (' the association") has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ("AASB") that are mandatory for the current reporting period.

The adoption of these Accounting Standards and Interpretations did not have a significant impact on the financial performance or position of the association

The following Accounting Standards and Interpretations are most relevant to the association:

Conceptual Framework for Financial Reporting (Conceptual Framework)

The association has adopted the revised Conceptual Framework from 1 October 2020. The Conceptual Framework contains new definition and recognition criteria as well as new guidance on measurement that affects several Accounting Standards, but it has not had a material impact on the association's financial statements

AASB 1060 General Purpose Financial Statements - Simplified Disclosures for For-Profit and Not-for-Profit Tier 2 Entities

The association has adopted AASB 1060 from 1 October 2020. This standard provides a new Tier 2 reporting framework with simplified disclosures. As a result of the early application of this standard, these financial statements have been prepared in accordance with Australian Accounting Standards – Simplified Disclosure. As permitted by AASB 1053 for early adoption of AASB 1060, comparatives information has not been provided for new disclosures

Basis of Preparation

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards – Simplified Disclosures issued by the Australian Accounting Standards Board (AASB) and the Associations Incorporation Act (SA) 1985. The association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

Historical cost convention

The financial statements have been prepared under the historical cost convention. The amounts presented in the financial statements have been rounded to the nearest dollar.

Critical Accounting Estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also required management to exercise its judgement in the process of applying the association's accounting policies. The ears involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant, are disclosed in note 1(o)

Accounting Policies

(a) Income Tax

South Australian Netball Association Incorporated is not subject to income tax and therefore no income tax expense or income tax payable is shown in the financial statements.

(b) Fair Value measurement

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

(c) Property, Plant and Equipment

Property, plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

The cost of fixed assets constructed within the association includes the cost of materials, direct labour and borrowing costs

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are recognised as expenses in profit or loss during the financial period in which they are incurred.

Depreciation is calculated on a straight-line or diminishing value basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

Buildings and leasehold improvements

Plant & equipment

Furniture, fixtures & fittings

Motor vehicles

Computer equipment

2.5 years to 40 years

1.5 years to 10 years

2.5 years to 5 years

4 years to 4.4 years

1.5 years to 2 years

The assets' residual values and useful lives are reviewed and adjusted, if appropriate, at the end of each reporting period.

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the association. Gains and losses on disposals are determined by comparing net proceeds with the carrying amount. These gains and losses are recognised in profit or loss in the period in which they occur. When revalued assets are sold, amounts included in the revaluation relating to that asset are transferred to retained surplus.

(d) Impairment of non-financial assets

Non-financial assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount.

Recoverable amount is the higher of an asset's fair value less costs of disposal and value-in-use. The value-in-use is the present value of the estimated future cash flows relating to the asset using a pre-tax discount rate specific to the asset or cash-generating unit to which the asset belongs. Assets that do not have independent cash flows are grouped together to form a cash-generating unit.

(e) Employee Provisions

Short-term employee benefits

Provision is made for the association's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly within 12 months of the reporting date. Short-term employee benefits are measured at the amounts expected to be paid when the obligation is settled.

Other long-term employee benefits

Provision is made for employees' annual leave and long service leave entitlements not expected to be settled wholly within 12 months of the reporting date. Other long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Consideration is given to expected future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations.

(f) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

(g) Accounts Receivable and Other Debtors

Accounts receivable and other debtors are recognised at amortised cost, less any allowance for expected credit losses.

(h) Revenue recognition

The association recognises revenue as follows:

Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the incorporated association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the incorporated association: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

Sales revenue

Events and fundraising are recognised when received or receivable.

Grant income

Grant revenue is recognised in profit or loss when the association satisfies the performance obligations stated within the funding agreements.

If conditions are attached to the grant which must be satisfied before the association is eligible to retain the contribution, the grant will be recognised in the statement of financial position as a liability until those conditions are satisfied.

Once the assets and liabilities have been recognised then income is recognised for any difference between the recorded asset and liability

Capital grants

Capital grants received under an enforceable agreement to enable the association to acquire or construct an item of property, plant and equipment to identified specifications which will be controlled by the association (once complete) are recognised as revenue as and when the obligation to construct or purchase is completed.

For construction projects, this is generally as the construction progresses in accordance with costs incurred since this is deemed to be the most appropriate measure of the completeness of the construction project as there is no profit margin.

For acquisitions of assets, the revenue is recognised when the asset is acquired and controlled by the association.

Interest Income

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

All revenue is stated net of the amount of goods and services tax.

) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST receivable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

(j) Inventories

Inventories held for sale are measured at the lower of cost and net realisable value.

(k) Accounts Payable and Other Payables

Accounts payable and other payables represent the liabilities outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(I) Contract liabilities

Contract liabilities represent the incorporated association's obligation to transfer goods or services to a customer and are recognised when a customer pays consideration, or when the incorporated association recognises a receivable to reflect its unconditional right to consideration (whichever is earlier) before the incorporated association has transferred the goods or services to the customer.

(m) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

(n) Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification. An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the incorporated association's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

(o) Critical Accounting Estimates and Judgements

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

Estimation of useful lives of assets

The association determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Impairment of non-financial assets other than goodwill and other indefinite life intangible assets

The association assesses impairment of non-financial assets other than goodwill and other indefinite life intangible assets at each reporting date by evaluating conditions specific to the incorporated association and to the particular asset that may lead to impairment. If an impairment trigger exists, the recoverable amount of the asset is determined. This involves fair value less costs of disposal or value-in-use calculations, which incorporate a number of key estimates and assumptions.

Employee Benefits

As discussed in note 1(e), the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

Coronavirus (COVID-19) pandemic

Judgement has been exercised in considering the impacts that the Coronavirus (COVID-19) pandemic has had, or may have, on the association based on known information. This consideration extends to the nature of the products and services offered, customers, supply chain, staffing and geographic regions in which the association operates. Other than as addressed in specific notes, there does not currently appear to be either any significant impact upon the financial statements or any significant uncertainties with respect to events or conditions which may impact the association unfavourably as at the reporting date or subsequently as a result of the Coronavirus (COVID-19) pandemic.

(p) Going Concert

The financial statements for the year ended 30 September 2021 have been prepared on a going concern basis. For the year ended 30 September 2021 the association recorded an operating surplus of \$629,723 (2020: \$311,809 loss) calculated as follows:

The 2021 surplus was impacted by extraordinary items if income including a once off government grant of \$700,000 and continuing job keeper and government subsidies of \$919,737.

- Management and costs restructure resulting in improved and profitable operations.

After taking into account all available information, the Board has concluded that there are reasonable grounds to believe:

- · The basis of preparation of the financial report on a going concern basis is appropriate.

No adjustments were made to the assets and liabilities within the financial statements in relation to this uncertainty.
