What a year we had in 2024!

2023 was historic for netball in South Australia and it opened doors for us at Netball SA to generate significant growth for our sport in 2024.

I'm beyond proud of our ability to not only capitalise on our previous successes but to add new achievements to our growing list of accolades.

In the second year of our Strategic Plan 2023-2026, we set substantial targets for our organisation to strive for and delivered strong results both on and off the court.

The Netball SA pathway continued to thrive, headlined by our 17U State Team securing the gold medal at Nationals, our Yakanarna side taking home silver at the inaugural First Nations Tournament, and our SA Rubies winning bronze at the Marie Little Shield.

Our Adelaide Thunderbirds Futures side debuted in the inaugural Super Netball Reserves competition and in front of a home crowd, the Adelaide Thunderbirds secured back-to-back premierships for South Australia.

In their new home at the Adelaide Entertainment Centre, the club eyed the opportunity to triple its attendance and grow its membership base – and you know what they say: build it and they will come.

With more than 56,000 through the doors in 2024, we were thrilled to see attendance soar by 115% as our Pink Army continued to grow exponentially.

With the spotlight well and truly on netball, we continued to lobby the government for a world-class facility for our netball community and in April,

SA Premier Peter Malinauskas announced a \$92 million redevelopment of Netball SA Stadium.

This investment is monumental for our sport across South Australia and we're excited to continue working with our stakeholders to develop the facility our community deserves.

As a Board, we were proud to complete the Netball Next project as our Netball SA Members unanimously voted in favour of our new Constitution.

As a result, our Council Subcommittee (CSC) was established, and we welcomed new Board Director Georgia Cadzow with a wealth of experience in netball administration.

In its initial meetings, the CSC established a twelve-month work plan, all based around assisting community clubs and associations to be the best they can be.

As I reflect on another historic year for netball in SA, I would like to thank our entire netball community for their unwavering and invaluable efforts in helping our sport thrive.

Thank you to all our volunteers, our coaches, umpires, administrators, and players all across the state, we would not experience the success we have without you.

Thank you to my fellow directors for your ongoing passion and commitment to growing netball at all levels.

Thank you to the members of the Audit and Risk Committee, Governance Committee, Nominations Panel, ATEP, Country Championships Organising Committee and our Council Delegates.

To our commercial partners, thank you for being with us in this historic year and your continued support of our netball community across South Australia. And to the team at Netball SA and our CEO Bronwyn Klei, thank you for your hard work and dedication to making

# **FROM THE CEO**

What another amazing year for netball in South Australia! I knew it would be hard to top the success of 2023, but we set out to dream bigger this year and the hard work paid dividends.

We celebrated immense success on court at all levels of the game, experienced significant growth off court in multiple areas of the business, and implemented governance initiatives that will take our sport forward in the future.

The year started with a bang as we welcomed the Malinauskas Government's \$92 million investment to redevelop Netball SA Stadium.

Following years of lobbying, we were proud to share this announcement with our netball community and ensure a world-class facility for the home of netball in South Australia.

After 18 months of the Netball Next project, our new Constitution was unanimously voted in by our Members.

Our Adelaide Thunderbirds made the official move to the Adelaide Entertainment Centre and we experienced unprecedented growth in the club's membership base and record numbers in attendance.

The new venue tripled the capacity of Netball SA Stadium, allowing our membership numbers to grow by 85% and our attendance by a significant 115%.

On court, our 17U State Team achieved the ultimate success to bring home the gold, while our 19U side finished sixth, and our SA Rubies secured the bronze medal at the Marie Little Shield tournament.

In a first for Super Netball, a Reserves competition was launched and our Adelaide Thunderbirds Futures had a successful debut season.

The Hospital Research Foundation Group Premier League competition continued to showcase the best netball talent South Australia has to offer.

In the League division, minor premiers South Adelaide secured a maiden appearance in the Grand Final and fell agonisingly one goal short of glory to Contax in a dramatic overtime, while it was Matrics who reigned in the Reserves with a two-goal win over Contax.

Our Adelaide Thunderbirds delivered a record-breaking season as they set new highest scores and margins on their way to securing their first minor premiership in 11 years.

South Australian athletes Lauren Frew and Kayla Graham made their Suncorp Super Netball debuts, while Jamaican star Latanya Wilson celebrated 50 SSN games in the pink dress.

Adding the cherry on top, the Thunderbirds secured backto-back premierships in front of a sell-out home crowd at the Adelaide Entertainment Centre.

The defending champions went undefeated at their new home and became the first club in national netball history to secure two back-to-back premierships.

Post-season, South Australian Georgie Horjus made her much-anticipated debut for the Australian Diamonds, joining teammate Matilda Garrett in the green and gold.

Fellow South Aussies Lucy Austin, Lauren Frew and Tayla Williams also pulled on the Australian colours in the Fast5 Netball World Series, where they secured a thirdconsecutive gold medal for their country.

At the Netball Australia Awards Night, five South Australians did us all proud with an array of awards.

Tania Obst was named SSN Coach of the Year, Georgie Horjus and Lauren Frew took out SSN Player of the Year and Rookie of the Year respectively, while Lucy Austin was selected as Fast5 Player of the Series.

In addition, SA netball icon and Thunderbirds legend Nat von Bertouch was inducted into the Netball Australia

Hall of Fame for her immense success and contributions to the sport.

Our South Australian Umpires and Bench Officials also excelled on the national and international stage, with Georgina Sulley-Beales officiating at both SSN and International Tests during the New Zealand vs England series.

Chloe Grosser, Charlotte Seidel and Tayana Sithole also received officiating call ups for both the National Netball Championships and SN Reserves in 2024.

Five South Australian Bench Officials officiated throughout the SSN season with Debbie Green, Naomi Davey and Robyn Kelly receiving the call up to officiate the Diamonds vs England match in Adelaide.


Our Country Championships event returned as just under 1,400 country netballers descended on Netball SA Stadium for the biggest weekend of netball for the year.

The 2024 event hosted 96 teams across 11&U, 13&U, 15&U, 17&U and Senior Grades over the three days of the June long weekend.

The introduction of our inaugural Yakanarna team headlined a series of developments in our First Nations Framework as the side secured a silver medal at the inaugural First Nations Tournament.

Another 12 scholarships were granted across the community and 20 athletes were selected in the Rising Sisters Aboriginal Netball Program.

Our Adelaide Thunderbirds School Holiday Clinics underwent a revamp to focus on skill development and positional clinics. These were well received and well attended with over 1500 netballers taking part.



This year, we also established an official MOU with the South Australian Men's and Mixed Netball Association to join forces in our efforts to increase male participation in netball.

A key element of the MOU was the elevation of the inaugural Men's Super League competition, which saw six of Netball SA's Premier Clubs introduce men's sides for the first time.

It's clear that 2024 has been incredible for netball in SA and we simply couldn't do it all without the help of the South Australian netball community.

Thank you to everyone who has contributed – our players, coaches, umpires, bench officials, and volunteers. Finally thank you to all of the amazing staff at Netball SA for everything they do week in week out to promote netball in our state.

In 2024 we were again proud to recognise our volunteers at the Netball SA Awards Gala for both metro and regional communities. For their






significant contributions, Lee-Anne Petherick from Contax Netball Club was awarded the metro award, while Susan Fox of Barmera Netball Club took out the country award.



## **MEMBERSHIP**

Netball SA experienced steady participation growth in 2024 and the Development Team were proud to continue supporting affiliated clubs and associations across the state.

In April, member delegates voted 100% in favour of adopting a new Constitution for Netball SA allowing for strong foundations and flexible structures which will future-proof netball Governance in South Australia.

2024 also saw the expansion of our men and boys capabilities with the signing of an memorandum of understanding between Netball SA and South Australian Mixed and Men's Netball Association.

Netball SA remains committed to supporting the growth and development of associations and clubs







- across South Australia. The netball team have visited regions across the state delivering education courses, support, skills and clinics.
- Our fortnightly Game Plan newsletter, specially designed for associations and clubs, continues to provide valuable content on governance, funding opportunities, product offerings, player development pathways, and club growth initiatives.
- Netball SA once again hosted its annual Awards Gala, celebrating all things netball in South Australia. Hundreds gathered at the Hilton Hotel as volunteers, coaches, players, and teams across the state at all levels of the game were recognised for their achievements.

# COUNTRY CHAMPIONSHIPS



Woolworths NetSetGo is netball's official starter program for kids aged 5 to 10.

A chance to learn the netball basics, Woolworths NetSetGo helps kids gain confidence, get active and make friends in a safe and inclusive environment.

Netball SA recorded over 1,300 participants in 2024, with 10 new centres added.

Woolworths NetSetGo on-court activations were held at two of the Adelaide Thunderbirds' seven home games, with a total of 40 program participants involved across the year.

### WOOLWORTHS NETSETGO CENTRE OF THE YEAR

In 2024 Netball SA announced its third Woolworths NetSetGo Centre of the Year with Loxton Netball Club taking out the title.

Loxton Netball Club were recognised for their work in providing a fun and inclusive program for the children of the Loxton District.

With 60 participants throughout 2024 taking part in one of their programs, they increased from 18 participants last year.

The LNC demonstrated the ability to support and guide their coaches to use the NSG program in a unique and interactive play having incorporated modified match play opportunities for their Go participants.

Furthermore, the club went above and beyond to secure grant funding, allowing them to buy all Go participants playing dresses for them to wear on game day.

In 2024 Woolworths NetSetGo underwent an extensive review with a new look program taking centre stage in 2025.

Held annually on the June long weekend, the Country Championships is the largest event on the netball calendar, attracting the best regional talent from across the state to Netball SA Stadium for a three-day competition.

In 2024, more than 1000 netballers participated as the best regional talent came together from across South Australia.

In addition, 23 country associations were represented as 96 teams competed in over 420 matches.

23 coaches and 21 umpires were mentored during the event and 13 umpires received national badges.

For the fourth consecutive year, Newscorp's live streaming arm – KommunityTV – covered the event, bringing the competition to the communities of all competing associations.

Netball SA would like to extend its gratitude to all who contributed to the event's success, in particular the Country Championships Organising Committee.

# **FIRST NATIONS**

Netball SA's First Nations Framework continued to grow in 2024, outlining Netball SA's commitment to increasing participation and development of Aboriginal and Torres Strait Islander netballers in South Australia.

Headlining a series of initiatives was the success of Netball SA's inaugural Yakanarna side who did their state and communities incredibly proud when they won the silver medal at the inaugural First Nations Tournament.

The Nunga Netball Carnival – South Australia's largest First Nations Tournament – returned to Netball SA Stadium as hundreds of netballers travelled from across the state to compete.

In a competition first, the recipients of the Yakanarna MVP Award and Netball SA's annual Vanessa Dempsey Award were announced during the event's opening ceremony.

In front of peers and community, Aaleya Turner was celebrated as the Yakanarna MVP and Darralee Gibson was named recipient of the Vanessa Dempsey Award.

Netball SA First Nations Frames initiatives in 2024 included:

- 12 First Nations Athlete Participation Scholarship recipients
- 56 teams in attendance for Nunga Netball Carnival, including the first ever Northern Territory representative team
- Nunga Netball Carnival live streamed for the second-consecutive year thanks to Netball SA's partnership with KommunityTV
- 24 Aboriginal and Torres Strait Islander netballers selected for 2024 Rising Sisters Program
- Inaugural Yakanarna side brought home silver from the inaugural First Nations Netball tournament
- Rising talent Aaleya Turner selected in inaugural Black Swans national side who debuted at the 2024 Pacific Netball Series
- Netball SA continued its ongoing partnership with the South Australian Aboriginal Secondary Training Academy's (SAASTA) netball academy
- Over 8,000 in attendance for the Adelaide Thunderbirds First Nations Round match at the Adelaide Entertainment Centre
- Adelaide Thunderbirds athletes wore their First

Nations Dress, designed by Shane Mankitya Cook, and both athletes and coaches wore shoes painted by SAASTA students in collaboration with artist Temaana Yundu Sanderson-Bromley

• Netball SA and Adelaide Thunderbirds staff also continued with cultural education sessions

### **WALKING NETBALL WOOLWORTHS RUBIES**

The Woolworths South Australian Rubies compete annually in the Marie Little Shield - named in honour of disability pioneer, Marie Little OAM.

The tournament has been running since 2013 and provides women with an intellectual disability the chance to compete at the national level and represent their state.

In 2024, the competition was held at Nissan Arena in Brisbane and ran across three days from Friday, September 6 to Sunday, September 8.

The Rubies delivered strong performances across the competition and secured bronze for the thirdconsecutive year.

For the first time, the Woolworths South Australian Rubies were recognised at the Netball SA Awards Gala event in October for their performance at the national event.

Competing in her 16th year, Rubies captain Isabella Ivancic-Holland was named Most Valuable Player of the entire Marie Little Shield competition in 2024 after starring across C, GD and GA.

Isabella was also crowned the 2024 Most Valuable Player on the back of another strong performance across the competition.

Netball SA's Walking Netball Program continued to gain momentum in 2024 as the modified version of the traditional game expanded to new centres across South Australia.

The program is aimed at improving health outcomes by encouraging physical activity, strength, balance, and fitness, as well as helping people of all ages and fitness levels stay active and social.

Heading into its third year, the product offers two key arms of the program: the activity sessions where participants practice their skills and improve their fitness and mobility in a fun and casual environment, as well as the Walking Netball competition where teams or individuals can nominate to play in a casual competition.

In 2024, the program expanded to offerings at Netball SA Stadium, Lights Community Centre, Barmera Netball Club, Port Lincoln Netball Association, Willunga Netball Club, Southern United Netball Association and Mt Barker Community Centre, almost double that of 2023.

Two South Australian Walking Netball teams also participated at the 2024 Australian Masters Games in Canberra.

# MEN & BOYS

The growth of male participation in netball was a strategic focus for Netball SA once again in 2024.

A key element of this strategy was the signing of a Memorandum of Understanding (MOU) with the South Australian Men's and Mixed Netball Association.

The MOU signified a sharing of resources and knowledge to increase development opportunities for men and boys in netball.

Together, both Netball SA and SAMMNA have a shared commitment to encouraging male participation at grassroots level, while also developing the pathway for men and boys to reach the elite level.

The inaugural Men's Super League hosted at Netball SA Stadium cultivated with South Adelaide Netball Club claiming the maiden premiership.

# **SCHOOLS PROGRAM**

Netball SA continues to provide opportunities for primary and secondary school students throughout South Australia to engage in netball, primarily through the Sporting Schools Program and Thunder Cup Competition.

### **SPORTING SCHOOLS**

The Sporting Schools program is an Australian Government initiative designed to help schools to increase children's participation in sport, and to connect them with community sporting opportunities. In 2024, the Sporting Schools program experienced a 19% increase in school bookings. Participating school netball programs were held across 20 primary schools and 22 high schools.

### THUNDER CUP

Thunder Cup is a participation-based competition for schools. The weekly competition delivered in Terms 2 and 3 enables children from years 3 to 8 to play netball and develop their skills.

The program had 560 students participating across the three age groups, with 10 schools submitting teams.

### **SPECIALIST SCHOOLS**

Specialist Schools Program was revamped in 2024 and two categories were introduced, allowing for Schools to select the program that best suits.

The aim of the Netball SA Specialist School Endorsement Program is: • To assist in the development of the sport and to raise the profile of netball within schools and the local

- community.
- To develop netball players to the best of their ability and to educate them for a potential career in the sporting industry.
- To provide an opportunity for school students to be developed for future talent identification in netball.



### SEDA COLLEGE (NOW SPORTS COLLEGE SA SCSA)

Netball SA and the Adelaide Thunderbirds are committed to providing SEDA (SCSA) students with valuable education, development, and participation opportunities in the industry. Throughout the year students can expect to experience a range of opportunities including:

- The opportunity to complete work placement at Netball SA
- · Coaching and umpiring accreditation and development
- Access to Adelaide Thunderbirds and Netball SA guest speakers that link to SCSA areas of study
- Deliver primary school coaching clinics on behalf of Netball SA and the Thunderbirds
- Work in fan activation and other departments for Thunderbird home games
- Assist with country championships in various capacities 40 students participated in the Netball program in 2024.





# **ADELAIDE THUNDERBIRDS TALENT ACADEMY**

Netball SA's Adelaide Thunderbirds Talent Academy returned in 2024 for the third year in its new format after a successful restructure in 2022.

The new format continued to evolve, taking a stronger focus on preparing athletes aged 14-16 for State Team trials and future pathway opportunities.

Five development academies returned with an average of 20 South Australian netballers spread across the locations: Jamestown, Keith, Metro, Port Lincoln, and Willunga.

The Emerging Academy also returned, with athletes from across the state talent identified to take part in this specialised academy.

In 2024, the program provided athletes with specialist training, including insight into sports psychology and fitness testing.

It also included access to Adelaide Thunderbirds specialist coaches and athletes and concluded with all participants invited to attend trials for Netball SA's 17U State Team.

At the conclusion of 2024, a player survey showed that 100% of athletes felt they developed as a player throughout the program, with 90% saying they would encourage others to participate.

# THE HOSPITAL RESEARCH FOUNDATION GROUP **PREMIER LEAGUE**

The Hospital Research Foundation Group Premier League is South Australia's pinnacle netball competition, comprising the state's best talent and fiercest rivalries.

It provides athletes, coaches, umpires, and officials with a highly competitive environment to showcase and develop their skills and is also an important feeder program for national opportunities within the netball pathway.

In 2024, Netball SA hosted two First Nations Rounds for the competition, aligning with Reconciliation Week and NAIDOC Week, and all eight clubs donned dresses with First Nations designs.

For an elevated ANZAC Round, the Australian Defence Force were invited to Netball SA Stadium to participate in the reciting of The Ode, Last Post and a minute's silence.

Ribbon Round returned in a greater format as Netball SA joined forces with principal charity partner The Hospital Research Foundation Group to raise vital funds and awareness for cancer research.

Held in conjunction with Netball SA's Adelaide Metropolitan Netball Division, the round raised \$5,694 for the cause.

Newscorp's live streaming arm - KommunityTV - extended their coverage of the competition to broadcast Court 1 games across the minor rounds





and all finals matches, with the Grand Finals once again streamed live via Kayo Sports.

The Reserves Grand Final saw modern rivals Matrics and Contax go head-to-head, with the Stars claiming victory by just 2 goals.

In the League division, South Adelaide made their historic maiden appearance in a Premier League Grand Final after defeating Garville by 18 goals in the Preliminary Final.

The big dance was one for the ages as Contax defended their title by 1 goal in a dramatic thriller that went to overtime.

# COACHING

# OFFICIATING

In 2024 there were a variety of opportunities for coaching development across South Australia including coach education workshops and selector workshops presented to over 100 participants.

These workshops were presented alongside Country Association visits and also incorporated mentors travelling to various regions to provide mentoring opportunities across the state, in addition to the mentoring provided at Country Championships.

The Back Bench Coach experience also returned in 2024 as coaches attended the workshop at the Adelaide Thunderbirds vs Melbourne Mavericks match at the Adelaide Entertainment Centre. The workshop was facilitated by Thunderbirds past premiership coach Jane Woodlands-Thompson and provided attendees with a unique experience to learn during a live SSN match.





Netball SA launched its inaugural Sideline Lens workshop at Round 6 at the Adelaide Entertainment Centre. Attendees had the opportunity to workshop the game between the Adelaide Thunderbirds and West Coast Fever and hear from both head coaches as well as High Performance Umpire Coach Dusty Gould. Match analysis took place during the game with discussion focusing on what happened on court from both an umpire and coach perspective.

Throughout the year, 10 presenters conducted various education sessions on the 2024 New INF Rule Update with over 700 participants attending.

In April, South Australian umpires Chloe Grosser, Charlotte Seidel and Tayana Sithole were selected to officiate at the 17/U and 19/U National Netball Championships and the inaugural SN Reserves competition.

SA umpire Georgina Sulley-Beales was once again given a Suncorp Super Netball contract to officiate at the top level, and, was also awarded the honour of officiating on the international stage during the New Zealand Silver Ferns vs England Roses series in October.

In a standout year, South Australian bench officials Debbie Green, Naomi Davey and Robyn Kelly were all selected to officiate the 2024 SSN Grand Final followed by all three receiving selection for the Australian Diamonds vs England Roses match in Adelaide.

At the Netball SA Award Gala, Barbara Reed was crowned Umpire of the Year (Community) and Chloe Grosser was Umpire of the Year for Premier League.

# **ADELAIDE THUNDERBIRDS**

The 2024 season was all about dreaming bigger for the Adelaide Thunderbirds as the reigning premiers of Suncorp Super Netball broke records both on and off the court.

A bigger home at the Adelaide Entertainment Centre, a bigger fan base as membership numbers reached new heights, and bigger stakes as the side prepared to defend its title.

The club welcomed experienced premiership players Romelda Aiken-George and Laura Scherian into the line-up, alongside local Lauren Frew who was elevated from training partner status to contracted player for 2024.

At their new home, the Adelaide Entertainment Centre, the club experienced a 115% increase in attendance numbers as more than 56,000 fans came to see the side in action. Membership numbers also increased by 85% as the Pink Army continued to rise.

On court, the side recorded its highest ever margin in Super Netball with 26 points over the Mavericks in Round 11 and its highest ever score with 73 against the Vixens in Round 12.

For the first time in 11 years, the Thunderbirds were crowned Minor Premiers and went undefeated at home, winning all seven minor round games at the Entertainment Centre.

In the Major Semi-Final, the side recorded the highest ever win in Super Netball finals history with a 25-point victory over the Vixens. The win booked their place in the Grand Final for the second-consecutive year, although this time the side would experience a home Grand Final at the Entertainment Centre.





- In front of a sold-out crowd, mostly decked out in pink, the Thunderbirds secured back-to-back premierships with a 2-point victory over the Vixens and secured the trophy for SA for another year.
- The win also meant the Thunderbirds went undefeated in Adelaide for the entirety of 2024.
- This season also marked the SSN debut of South Australian shooter Kayla Graham who became Thunderbird #111 in Round 8.
- Five South Australians were selected as training partners: Nyah Allen, Sophie Casey, Kayla Graham, Tyler Orr and Molly Watson, with Orr elevated to the side's inaugural 11th player.
- Jamaican international Latanya Wilson celebrated her 50th SSN game in Round 7 as the side defeated the Swifts by 25 goals at home.
- In June, Matilda Garrett was named in the Australian Diamonds squad for the second-consecutive year and for the first time, South Australian Georgie Horjus was also named in the squad and Adelaide local Lucy Austin was named as an invitee.
- In October, Kangaroo Island product Horjus became the first South Australian Thunderbird to debut for the Diamonds since Laura von Bertouch in 2006.
- The following month, Austin made her thirdconsecutive appearance in the Australian Fast5 side at the World Fast5 Series in New Zealand. She was joined by teammates Tayla Williams, who was named for the second time, and Lauren Frew who made her debut appearance in the green and gold as Australia secured their third title in three years.

# **ADELAIDE THUNDERBIRDS FUTURES**

The Adelaide Thunderbirds Futures program grew in 2024 as the side made its debut in the inaugural Super Netball Reserves competition.

# **STADIUM**

Netball SA Stadium continued to host outstanding events in 2024 as the venue capitalized on availability created by the Adelaide Thunderbirds' move to the Adelaide Entertainment Centre.

The Stadium was privileged to host 2024 Wheelchair Rugby National Championships in May as talented athletes from all over the world descended on Mile End for the event.

The thrilling wheelchair clashes, paired with the strength, toughness, and unwavering determination of the competitors, created an unforgettable spectacle. A highlight of the year's events calendar, the Stadium is excited to once again host the event in 2025.

Regular competitions maintained strong attendance and Netball SA was able to provide financial relief by lowering the cost of ticketing and streamlining its online purchasing process.

The Hospital Research Foundation Group Premier League, Adelaide Metropolitan Netball Division, City Night Division, and the newly launched SAMMNA Super League all continued to draw significant numbers to the venue.

The introduction of themed nights kicked off with CND's Neon Nights in November and was followed by the competition's Christmas Round on December 13.



- Several School Carnivals were hosted at the venue along with the popular Hospital Research Foundation Group Adelaide Thunderbirds School Holiday Clinics, which experienced their highest participation numbers yet.
- Major events Cheercon and Aussie Gold returned, now choosing Netball SA Stadium as a regular venue in their yearly calendars. Cultural events also featured in the busy calendar with Dance Garbas and a Bollywood concert.
- The venue recorded a busy November, with the Special Olympics State Games Opening Ceremony, the Premier's Be Active Challenge Reception and the annual Kids & Youth with Disabilities eXpo (Kyd-X).
- Paddles and pickleballs featured again over the 2024 season with enormous growth in participation for this fast-growing sport. A hybrid of tennis, badminton and table-tennis, Pickleball featured in Netball SA stadium's weekly calendar.
- Netball SA is delighted to work with such a broad range of promoters to help bring their events to life and ensure their patrons and guests are well-catered for whilst on site.
- The food and beverage team does an amazing job of ensuring the many patrons have a variety of food offerings available to them whilst in attendance, with offerings expanding during 2024.







# **MARKETING & COMMUNICATIONS**

Netball SA's Marketing and Communications arm continued to promote the sport in South Australia and beyond, from grassroots to the elite level.

Key campaigns and communications support the Netball SA, Adelaide Thunderbirds, Premier League and Netball SA Stadium brands.

In 2024, the focus on membership and ticketing was elevated by the Adelaide Thunderbirds' move to the Adelaide Entertainment Centre – a venue with triple the capacity of Netball SA Stadium.

Both areas were supported by the 'Dream Bigger' campaign – an evolution of the club's successful 2023 Dare to Dream campaign – which highlighted three key elements: a bigger stage, a bigger fanbase, and bigger stakes.

The campaign was integrated across owned channels, earned media and paid digital advertising, as well as radio with Nova and an elevated presence in outdoor media with JC Decaux.

An elevated digital advertising campaign for ticketing and corporate hospitality offerings reached over 1.3 million accounts and a 30% click conversion rate.

The campaign experienced a strong return on investment as the club experienced record attendance with an increase of 115% on 2023, and record membership numbers with an 85% increase.

The club averaged 8,000 attendees per game, sold out two matches, and recorded its highest-ever Suncorp Super Netball attendance in Round 14 with 9,248.

An elevated digital strategy resulted in significant growth in exposure for both the Netball SA and the Adelaide Thunderbirds brands as the digital footprint increased by a combined average of 13.2 percent.

Netball SA extended its partnership with Newscorp's live streaming arm KommunityTV to secure coverage of the Hospital Research Foundation Premier League, the Country Championships, and the Nunga Netball Carnival.

Ongoing advertising of the Adelaide Thunderbirds school holiday clinics experienced a positive return on investment, with participation numbers increasing to 1640 overall and July recording record numbers with 719 – a 35% increase on the existing record from July 2022. Adelaide Thunderbirds and the Suncorp Super Netball saw unprecedented growth in 2024 which was also reflected in viewership. 2024 was the most watched season ever, delivering the league's third consecutive year of viewership growth. An average audience per game of 57,000 resulted in an 18% increase year on year.

Streaming audiences also continued to increase, with 63% of the audience now enjoying netball on Kayo Sports, Foxtel Now and Foxtel Go. In total across the season and final series, there were more than 210 million minutes streamed across all matches.

Adelaide Thunderbirds had a strong show of support in viewership numbers throughout the season, with a spike across the finals series as the team went back-to-back.







# FINANCIAL

# **COMMERCIAL PARTNERS**

In 2024, Netball SA welcomed a series of new partnerships to help grow the game of netball in South Australia.

The organisation welcomed the Construction Industry Training Board (CITB) as a major partner, who launched their Trade Up campaign in front of 9,000+ fans in Round 12 to empower women to explore a career in construction.

Sixt also joined as a major partner and official car rental company, while Nova became the official radio partner.

The Department for Human Services came aboard to promote the Here for the Game campaign to disrupt the normalization of gambling in sport and reinforce the love of the game.

Netball SA welcomed Westfield with a local partnership, to extend from the league-wide partnership, which included Matilda Garrett as their hero ambassador.

The Adelaide Thunderbirds launched its inaugural Play 4 Pink Round with principal charity partner, The Hospital Research Foundation Group, to raise vital funds for breast cancer research.

Indicative of the success of the round, the Pink Army got behind the cause and helped raise over \$30,000 in fundraising.

The club unveiled a new official Adelaide Thunderbirds dress, with apparel partner Valour Sport, which signified stepping into a new era at the Adelaide Entertainment Centre.

The Netball SA community lottery continued to raise vital funds in grassroots netball right across the state, with \$40,000 going directly back to clubs.

Netball SA's commercial team rounded out the year on a high, securing a new principal partner, Adelaide University.

The partnership will support netball right across the state, from grassroots to elite in a historic three-year deal for netball in South Australia.

2024 created a special opportunity for Netball SA and the Thunderbirds to celebrate back-to-back premierships and a first historic season at the Adelaide Entertainment Centre with both renewing and new partners.

Netball SA would like to thank its partners for their ongoing support of netball in South Australia and we look forward to working together to enrich our netball community, on and off the court.



# MEMBERSHIP & TICKETING

The Adelaide Thunderbirds membership base reached new heights in 2024 as the club experienced significant growth following the move to the Adelaide Entertainment Centre.

In its first season in their new home, the club reached over 4,300 members, recording an 85% increase from 2023.

The club introduced a new premium membership category, Captain's Courtside, which experienced a strong uptake in its first year and allowed fans to watch the game from the best seats in the house.

The Cobb's Hill Deck corporate hospitality offering was also introduced at all games, which brought the winery to the netball and was featured at the 2024 SSN Grand Final.

In what was a historic year for netball across the country, the 2024 SSN season was the most attended season ever in Australian women's sport.

For the Thunderbirds, their new venue meant crowds grew by an emphatic 115% from 2023 as more than 56,000 attended games across the season.

The club sold out multiple matches and achieved its highest crowd ever in SSN minor round history with 9,248 in attendance in Round 14.

The 2024 SSN Grand Final in Adelaide also smashed attendance records with 9,694 in the venue.







# OPERATING PERFORMANCE

Netball SA achieved a successful year financially, powered by strong, statewide participation, an increase in commercial partnerships, and back-to back Suncorp Super Netball Premierships with the Adelaide Thunderbirds.

Our financial position remains strong, with no current borrowings and strong liquidity. Our cash reserves improved over the reporting period, with a robust reserve fund established to enable the organisation to achieve strategic successes into the future.

The transition of the Thunderbirds home games to the Adelaide Entertainment Centre proved to be a major success, on and off the court. The move allowed the Thunderbirds to engage with more fans than ever across the 2024 season, with home game capacity tripling. The resulting increase in Thunderbird memberships and ticket sales generated additional income of more than \$1m. While match-day expenses also increased as part of the move, overall Netball SA consumer revenue exceeded expectations at the end of the reporting period.

The relocation and eventual Premiership also produced an increase in corporate sponsorships, with this upward trend expected to continue in 2025.

Grassroots netball maintained its status as the number one team sport for women and girls, with strong memberships and player participation numbers within clubs and associations across South Australia.

During the year, Netball SA adopted a new constitution which brought our financial year in-line with most other Australian member organisations. This saw our year-end reporting date change from 30 September to 31 December, and therefore, the financial results included in this report cover a 15-month period instead of the normal 12 months.

Understandably, this one-off change has had a material impact on our financial results, with the additional months – September to December – being 'out-going' months when expenses and salaries traditionally outweigh income, which is always concentrated towards the start of the year.

With that understanding, Netball South Australia recorded an operating loss for the 15-months ended 31 December 2024 of \$24,987 before the calculation of statutory expenses, which was an improvement from the prior year loss. In recognition of the Netball SA stadium redevelopment, planned to commence in 2025, we reported an accelerated non-cash depreciation expense relating to the netball stadium, which has significantly impacted the overall operating deficit result.

The year ahead for Netball SA will be impacted by the commencement of the Mile End Stadium redevelopment which will disrupt normal business operations. The Board and the Executive team are now preparing a detailed strategy to mitigate risk and minimise any disruption.

We thank the South Australian government for their on-going support which enabled the organisation to take the sport of netball to a bigger stage in 2024. This key partnership will also be critical throughout the coming 12 months as we embark on the stadium redevelopment - one of the most exciting projects Netball SA has seen and one which will ensure the future sustainability of the sport we all love.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE FIFTEEN MONTHS ENDED 31 DECEMBER 2024

### NOTE 1 - MATERIAL ACCOUNTING POLICIES

The financial statements cover South Australian Netball Association Incorporated as an individual entity. South Australian Netball Association Incorporated is an association incorporated in South Australia and operating pursuant to the Associations Incorporation Act (SA) 1985.

The material accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

### New or amended Accounting Standards and Interpretations adopted

South Australian Netball Association Incorporated ("the association") has adopted all of the new or amended Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ("AASB") that are mandatory for the current reporting period.

Any new or amended Accounting Standards or Interpretations that are not yet mandatory have not been early adopted.

### **Basis of Preparation**

The financial statements are general purpose financial statements that have been prepared in accordance with Australian Accounting Standards - Simplified Disclosures issued by the Australian Accounting Standards Board (AASB) and the Associations Incorporation Act (SA) 1985. The association is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in financial statements containing relevant and reliable information about transactions, events and conditions. Material accounting policies adopted in the preparation of the financial statements are presented below and have been consistently applied unless stated otherwise. The financial statements, except for the cash flow information, have been prepared on an accruals basis and are based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest dollar.

### Change in financial year end

The Association has changed its financial year-end from 30 September 2024 to 31 December 2024. As a result, the current financial statements cover a period of fifteen months from 1 October 2023 to 31 December 2024. This change has been made to align with all other Australian member organisations and the new Constitution.

Due to this change, the amounts presented in the financial statements may not be directly comparable with those of the previous financial year, which covered a 12 month period from 1 October 2022 to 30 September 2023.

### Critical Accounting Estimates

The preparation of the financial statements requires the use of certain critical accounting estimates. It also required management to exercise its judgement in the process of applying the association's accounting policies. The years involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant, are disclosed in note 1(o)

### **Accounting Policies**

### Income Tax (a)

South Australian Netball Association Incorporated is not subject to income tax and therefore no income tax expense or income tax payable is shown in the financial statements.

### Fair Value measurement (b)

When an asset or liability, financial or non-financial, is measured at fair value for recognition or disclosure purposes, the fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date; and assumes that the transaction will take place either: in the principal market; or in the absence of a principal market, in the most advantageous market.

Fair value is measured using the assumptions that market participants would use when pricing the asset or liability, assuming they act in their economic best interests. For non-financial assets, the fair value measurement is based on its highest and best use. Valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, are used, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

### Property, Plant and Equipment (c)

Property, plant and equipment is stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

The cost of fixed assets constructed within the association includes the cost of materials, direct labour and borrowing costs.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the association and the cost of the item can be measured reliably. All other repairs and maintenance are recognised as expenses in profit or loss during the financial period in

### Depreciation

which they are incurred.

Depreciation is calculated on a straight-line or diminishing value basis to write off the net cost of each item of property, plant and equipment (excluding land) over their expected useful lives as follows:

Buildings and leasehold improvements Plant & equipment Furniture, fixtures & fittings Computer equipment

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the association. Gains and losses on disposals are determined by comparing net proceeds with the carrying amount. These gains and losses are recognised in profit or loss in the period in which they occur. When revalued assets are sold, amounts included in the revaluation relating to that asset are transferred to retained surplus.

### Impairment of non-financial assets (d)

At the end of each reporting period, the association reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, is compared to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in profit or loss.

Where it is not possible to estimate the recoverable amount of an individual asset, the association estimates the recoverable amount of the cash-generating unit to which the asset belongs.

The association is writing off the balance of leasehold improvements over a two year period. This accelerated depreciation reflects the redevelopment of the Netball SA stadium (refer to Note 15), at which point it will no longer hold any residual value. This approach aligns with the association's policy to match the assets useful life with its anticipated economic benefits.

### (e) Employee Provisions

Short-term employee benefits

Provision is made for the association's obligation for short-term employee benefits. Short-term employee benefits are benefits (other than termination benefits) that are expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service, including wages, salaries and sick leave. Short-term employee benefits are measured at the (undiscounted) amounts expected to be paid when the obligation is settled.

The association's obligations for short-term employee benefits such as wages, salaries and sick leave are recognised as a part of current trade and other payables in the statement of financial position.

### Other long-term employee benefits

Provision is made for employees' annual leave entitlements not expected to be settled wholly within 12 months after the end of the annual reporting period in which the employees render the related service. Other long-term employee benefits are measured at the present value of the expected future payments to be made to employees. Expected future payments incorporate anticipated future wage and salary levels, durations of service and employee departures, and are discounted at rates determined by reference to market yields at the end of the reporting period on government bonds that have maturity dates that approximate the terms of the obligations. Any remeasurements of obligations for other long-term employee benefits for changes in assumptions are recognised in profit or loss in the periods in which the changes occur.

The association's obligations for long-term employee benefits are presented as non-current provisions in its statement of financial position, except where the association does not have an unconditional right to defer settlement for at least 12 months after the reporting date, in which case the obligations are presented as current provisions.

### (f) Cash and Cash Equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

### (g) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from customers in the ordinary course of business. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Accounts receivable are initially recognised at fair value and subsequently measured at amortised cost using the effective interest method, less any provision for impairment. Refer to Note 1(d) for further discussion on the determination of impairment losses.

### Revenue recognition (h)

The association recognises revenue as follows:

Revenue from contracts with customers

Revenue is recognised at an amount that reflects the consideration to which the association is expected to be entitled in exchange for transferring goods or services to a customer. For each contract with a customer, the association: identifies the contract with a customer; identifies the performance obligations in the contract; determines the transaction price which takes into account estimates of variable consideration and the time value of money; allocates the transaction price to the separate performance obligations on the basis of the relative stand-alone selling price of each distinct good or service to be delivered; and recognises revenue when or as each performance obligation is satisfied in a manner that depicts the transfer to the customer of the goods or services promised

Variable consideration within the transaction price, if any, reflects concessions provided to the customer such as discounts, rebates and refunds, any potential bonuses receivable from the customer and any other contingent events. Such estimates are determined using either the 'expected value' or 'most likely amount' method. The measurement of variable consideration is subject to a constraining principle whereby revenue will only be recognised to the extent that it is highly probable that a significant reversal in the amount of cumulative revenue recognised will not occur. The measurement constraint continues until the uncertainty associated with the variable consideration is subsequently resolved. Amounts received that are subject to the constraining principle are recognised as a refund liability.

### Membership income

Membership revenue is recognised on a straight line basis over the period of the membership.

### Sales revenue

Events and fundraising revenues are recognised when received or receivable.

Grant income

Grant revenue is recognised in profit or loss when the association satisfies the performance obligations stated within the funding agreements.

If conditions are attached to the grant which must be satisfied before the association is eligible to retain the contribution, the grant will be recognised in the statement of financial position as a liability until those conditions are satisfied.

Once the assets and liabilities have been recognised then income is recognised for any difference between the recorded asset and liability

### Capital grants

Capital grants received under an enforceable agreement to enable the association to acquire or construct an item of property, plant and equipment to identified specifications which will be controlled by the association (once complete) are recognised as revenue as and when the obligation to construct or purchase is completed.

For construction projects, this is generally as the construction progresses in accordance with costs incurred since this is deemed to be the most appropriate measure of the completeness of the construction project as there is no profit margin.

For acquisitions of assets, the revenue is recognised when the asset is acquired and controlled by the association.

### Interest Income

Interest revenue is recognised as interest accrues using the effective interest method. This is a method of calculating the amortised cost of a financial asset and allocating the interest income over the relevant period using the effective interest rate, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the net carrying amount of the financial asset.

### Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established. All revenue is stated net of the amount of goods and services tax.

### Goods and Services Tax (GST) (i)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

### Inventories (i)

Inventories held for sale are measured at the lower of cost and net realisable value.

### Accounts Payable and Other Payables (k)

Accounts payable and other payables represent the liabilities outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

### Contract liabilities (I)

Contract liabilities represent the association's obligation to transfer goods or services to a customer and are recognised when a customer pays consideration, or when the association recognises a receivable to reflect its unconditional right to consideration (whichever is earlier) before the association has transferred the goods or services to the customer.

(m) Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions recognised represent the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Current and non-current classification

Assets and liabilities are presented in the statement of financial position based on current and non-current classification.

An asset is classified as current when: it is either expected to be realised or intended to be sold or consumed in the association's normal operating cycle; it is held primarily for the purpose of trading; it is expected to be realised within 12 months after the reporting period; or the asset is cash or cash equivalent unless restricted from being exchanged or used to settle a liability for at least 12 months after the reporting period. All other assets are classified as non-current.

A liability is classified as current when: it is either expected to be settled in the association's normal operating cycle; it is held primarily for the purpose of trading; it is due to be settled within 12 months after the reporting period; or there is no unconditional right to defer the settlement of the liability for at least 12 months after the reporting period. All other liabilities are classified as non-current.

### Critical Accounting Estimates and Judgements (0)

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. Management continually evaluates its judgements and estimates in relation to assets, liabilities, contingent liabilities, revenue and expenses. Management bases its judgements, estimates and assumptions on historical experience and on other various factors, including expectations of future events, management believes to be reasonable under the circumstances. The resulting accounting judgements and estimates will seldom equal the related actual results. The judgements, estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities (refer to the respective notes) within the next financial year are discussed below.

### (i) Useful lives of property, plant & equipment

The association determines the estimated useful lives and related depreciation and amortisation charges for its property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation and amortisation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

### (ii) Employee benefits provision

As discussed in note 1(e), the liability for employee benefits expected to be settled more than 12 months from the reporting date are recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, estimates of attrition rates and pay increases through promotion and inflation have been taken into account.

### NOTES TO THE FINANCIAL STATEMENTS FOR THE FIFTEEN MONTHS ENDED 31 DECEMBER 2024

For the purpose of measurement, AASB 119: Employee Benefits defines obligations for short-term employee benefits as obligations expected to be settled wholly before 12 months after the end of the annual reporting period in which the employees render the related service. As the association expects that all of its employees would use all of their annual leave entitlements earned during a reporting period before 12 months after the end of the reporting period, the association believes that obligations for annual leave entitlements satisfy the definition of short-term employee benefits and, therefore, can be measured at the (undiscounted) amounts expected to be paid to employees when the obligations are settled.

### (iii) Accruals

The Accruals at reporting date have been reviewed to determine whether there is any objective evidence that any of the accruals are payable. A payable provision is included for any accrual where the entire balance is not considered received. The provision is based on the best information at the reporting date.

### (iv) Performance obligations under AASB15

To identify a performance obligation under AASB 15, the promise must be sufficiently specific to be able to determine when the obligation is satisfied. Management exercises judgement to determine whether the promise is sufficiently specific by taking into account any conditions specified in the arrangement, explicit or implicit, regarding the promised goods or services. In making this assessment, management includes the nature/ type, cost/value, quantity and the period of transfer related to the goods or services promised.
